

## Portfolio objective

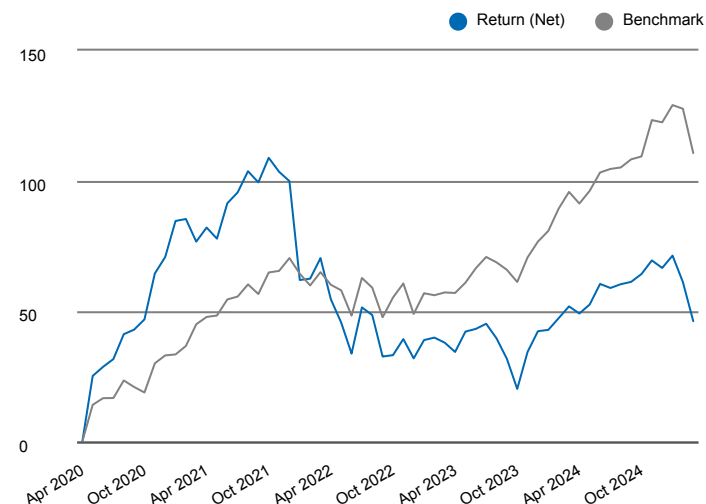

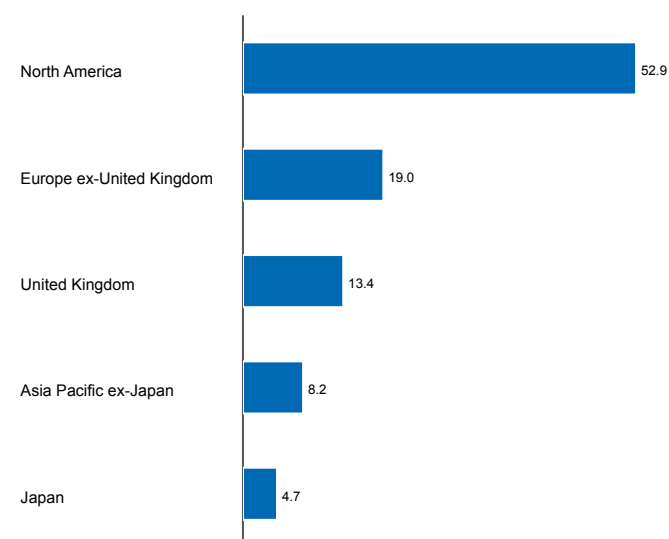
